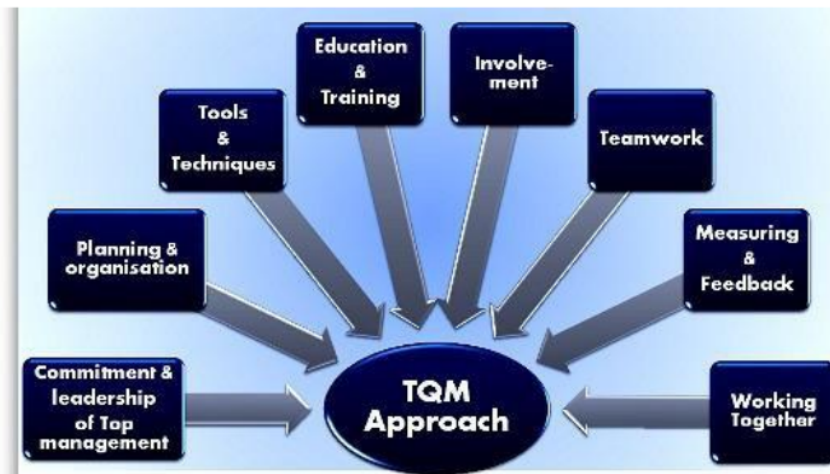


Figure 2.Total Quality Management Approaches

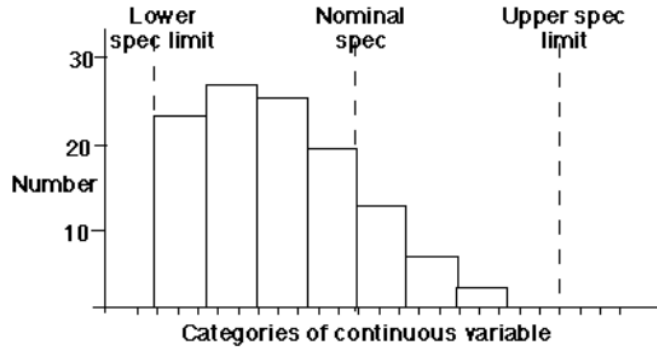


Figure 3. TQM tools categories

7. Control chart: The adjustments in the process after some time are depicted in charge diagrams. Figure 3 shows TQM tools categories

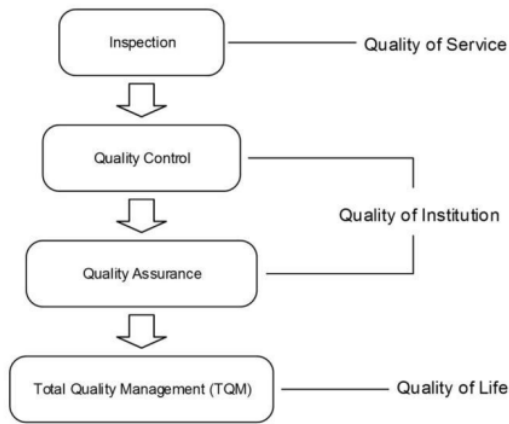


Figure 4. Implementing the TQM

TQM implanting basic model are shown in figure 4 given below

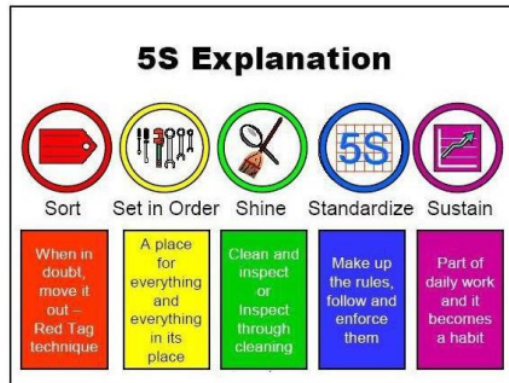


Figure 5. Applications of TQM

associations [5]. It is the arrangement of uncommon consumer loyalty's. It depends on the participatory administration theory. Figure 5 shows applications of TQM.

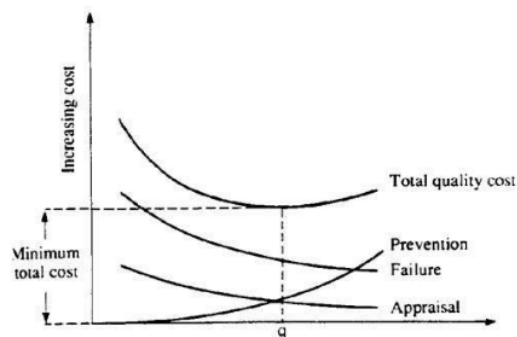


Figure 6. System of total quality management

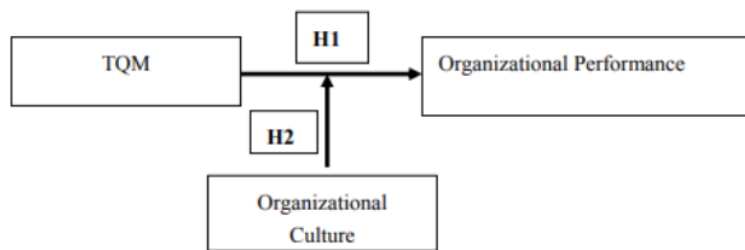


Figure 7. Research model

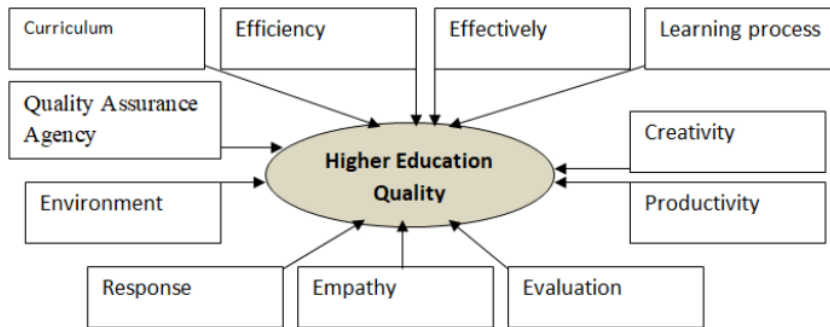


Figure8. Islamic College Quality and Its Attributes

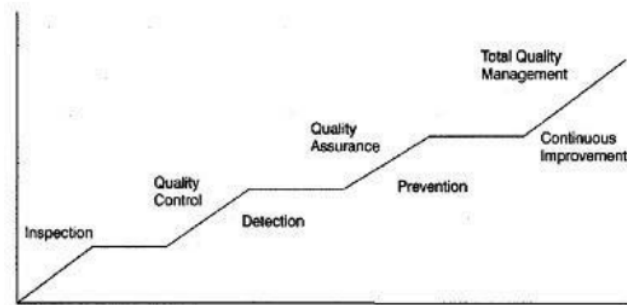


Figure 9.Quality Concept Hierarchy
