Reviewer's COMMENTS

"Introduction :

1. very little primary data as an introduction to research.
2. There is no gap between current research and previous research. (although in the discussion section there are previous studies in the introduction, the author needs to state what the differences are between this research and previous research and state what the contribution of this research is
3. The research objectives are not in sync with the objectives written in the abstract. in the abstract of satisfaction in the introduction about information gaps. In addition, the purpose of the introduction is not explained properly and explicitly.

Suggestion ;

The author needs to improve the initial data of the study and clearly indicate the main problem of the data. so that the introduction does not seem just a story and the author's own opinion. In addition, the author cites very few comparisons of research in this chapter.

Literature Review

Enough

Method :

The method used is quite good, it's just that only 111 respondents were collected to represent Indonesia, I think this is still lacking and has an impact on unsatisfactory research results.

Results and discussion

Enough. but because the number of respondents is lacking, I don't think it has a significant impact.

Conclusion.

The author repeats what was discussed. the conclusion should only answer the author's three objectives without repeating the results of the study.

Revision

1. The author needs to synchronize the research objectives between the abstract, the introduction. discussion and conclusion.
2. The writer needs to write explicitly what is the contribution of this research.

3. In this section, the author's method needs to be reassured why this 111 can represent the Indonesian nation? other than the reasons according to the method. or whose theory states that these 111 could represent one country.
4. If it is possible to increase the impact of the research, the authors suggest increasing the sources of respondents from eastern Indonesia, which have very different cultures.
5. The author needs to add research limitations and what are the author's suggestions for previous research."
